VII. Reports:

Director's Report (verbal)

I met with Mr. Green regarding his questions about trees near the seawall. In general, trees near the seawall are not encouraged due to the potential damage from their root system. The number of volunteer trees which sprout up near the wall will be reduced or eliminated subsequent to the recent project. The ground behind the wall was graded to allow property owners to mow close to the wall and the flat concrete surface allows easy weed wacking eliminating unwanted growth.

The RDA received four bids which were opened on September 22, 2016 at 11:00 am at Frenchtown Hall. The low bid was submitted by Wolverine Seal Coating for \$63,600, which is below the amount approved by the board at the September meeting. After consulting with Mr. McDevitt per the board directive a contract was entered into. We expect this work to be completed the last week of October.

Six submittals were received pursuant to the RDA Legal Advisor Request for Qualifications. The Search Committee will meet to review the submittals and schedule interviews. Our plan is to have a recommendation at the November Board Meeting.

There was discussion and general agreement on increasing the RDA budget from \$275,000 to \$300,000 yearly for road maintenance which will cover the micro-surfacing and patching the district roads annually.

FEMA Coastal Floodplain Preliminary Work Map

Mark Mathe with Mannik & Smith Group (RDA Engineer) presented a handout comparing the new proposed map with the currently adopted map for the RDA and the township. The new map takes into consideration wave action as well as elevation.

The Director intends to take advantage of the open comment period and send a letter to FEMA outlining the many flood risk reduction actions, such as storm sewer pumps and seawall rehabilitation, taken by the RDA to ensure they are considered in the analysis.
